The Toombs County Board of Commissioners, in conjunction with the Cities of Lyons, Santa Claus, and Vidalia, is initiating a process to update the current countywide joint comprehensive plan, in accordance with Georgia law. While this plan is necessary to maintain local government eligibility for

state grants, loans, and permits, it is also an important blueprint for addressing local concerns and establishing a guide for community growth and development. The assistance and involvement of the entire community is needed, both public and private sectors.
