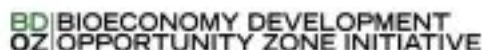

*The BDO Zone Initiative has issued an 'AA' BDO Zone rating for Toombs County, Georgia for 1,015,000 bone dry tons per year of woody biomass.*

A highly productive forest products industry along with well-established supply chains guarantee a stable and efficient supply of biomass.
